- (i) The members considered and approved unanimously the Draft Letter Of Offer (DLOF) for seeking in-principle approval of the Stock Exchanges for issuance of fully paid-up equity shares of the Company aggregating upto Rs. 49.30 Crores at such ratio, price & terms and conditions as may be determined by the empowered Right Issue Committee of the Board of Directors in this regard, as per the applicable statutory provisions, to the existing equity shareholders of the Company as on the record date to be fixed for the purpose at appropriate time. .
- (ii) The Members authorised the CS & Compliance Officer of the Company to furnish the DLOF to the Stock Exchange and to entertain all subsequent interaction with the Stock Exchanges and other Regulator(s) to obtain the in-principle approval to the DLOF and ensure compliance of the applicable terms of SEBI (ICDR) and SEBI (LODR),
- (iii) Members also recorded appointment of various intermediaries for the purpose of the ensuing Rights Issue.
